

Stud Service Agreement

Terms:

The fee for this service is: \$_____ the amount of \$_____ is to be paid at the time of drop off and remaining balance of \$_____ is due upon pickup.

Bitch owner agrees -

1. To provide a current negative Brucellosis test prior to mating and Bitch must be negative of external and internal parasites. Bitch owner must show documentation from a vet. The Bitch must be in good health.
2. To provide a **four generation pedigree** to the stud owner.
3. Permission to have the dog treated in case of injury and pay any veterinary costs while the dog is in our care. **Initials:** _____
4. That the bitch has not been exposed to another stud dog and will not be exposed to another stud dog while in season.
5. To notify the stud dog owner in writing no later than 30 days after mating if no pregnancy results from the mating. Failure to do so will result in no return service being provided.
6. To pay the agreed stud service fee before mating occurs or to give the stud dog owner first pick of the litter before any puppy from the litter is promised. The stud dog owner has until the litter reaches 6 weeks old to choose.
7. That one puppy born alive constitutes a litter. If pregnancy does not occur, or there are no live births, a repeat breeding will be given to the same bitch on her next season. Owners of the bitch must have a signed document for a vet of my choice stating that pregnancy didn't accrue no later than 30 days after mating.
8. If the bitch fails to conceive on the return service, this contract is terminated.
9. Bitch owner is responsible for the cost of food, supplements, and medication while in the care of the stud dog owner. A boarding fee of \$5 a day is charged if female stays longer than five (5) days.
10. Any damages made to the stud owner's property by the bitch due to lack of training on the bitch owner's part will be charged on the day of pick up.
11. No puppies resulting from the breeding may be sold to brokers, pet shops, or puppy mills. Should this part of the contract be ignored stud dog owner will pursue this clause in a court of law.
12. Bitch owner agrees to provide stud dog owner with a list of names and addresses of owners of the puppies resulting from this breeding along with AKC names and numbers of each puppy.

Stud dog owner agrees –

1. That dog is in good health and free of internal and external parasites.
2. To provide a **four generation pedigree** to the bitch owner.
3. To sign litter registration papers once the terms of the agreement have been met.
4. To provide a return service at no charge to the same bitch on her next heat or within 1 year if pregnancy fails to occur on the first mating or no puppies are born alive provided all conditions of this agreement have been met.
5. Bitch will be treated like one of the stud dog owners own animals when in care of the stud dog owner. Stud dog owner has a large fenced area, kennel run, and bitch will be kept inside owner's home during her stay. She will be exercised, played with, and pampered during her stay. Being away from home is difficult for some animals and stud dog owner will make his/her greatest effort to make sure she will feel comfortable during her stay.

Conditions:

Additional Options:

Once puppies are born stud dog owner agrees to post the puppies on the website for an additional \$300. It is the bitch owners' responsibility to provide the new owners with all documentations including contracts, AKC papers, and health records for the puppies. It is also bitch owners responsibility to send WEEKLY individual pictures of the puppies to the stud dog owner. All puppies must be given first round of shots, dewclaw removed, deworming, and proper socialization to adults, kids, and other animals in order to be posted on my website.

Upon the signing of this agreement, I do hereby swear that I am the owner of this bitch and have legal right to breed her. I also agree that I understand and agree the terms set forth in this agreement.

Additional Information:

Dogs must be registered by the American Kennel Club.

1. Bitch owner must provide current photographs which must include side shot, mug shot, and any other photographs the owner believe will assist in evaluating breeding potential.
2. We must see proof of a complete health check-up by a veterinarian, as well as a negative Brucellosis test no more than thirty (30) days prior to the breeding. We also need proof that she is current on vaccinations and free of internal and external parasites.
3. The owner must provide us with written permission to have the dog treated in case of injury and pay any veterinary costs while the dog is in our care.
4. It is the owner's responsibility to be sure that the dog is brought at the proper time for breeding.
5. The owner is required to pay all transportation costs. The owner is responsible for finding out airport pick-up and delivery fees. We will charge \$75 toward gasoline if I have to pick up the bitch from the Airport in DALLAS. All fees are to be paid before the dog is shipped.
6. I am not responsible for any injury to the dog if any should occur while in the act of breeding.
7. Dogs that cannot be bred due to viciousness, fear, or any other extreme behavior problem will be immediately returned to the owner and no payment will be due.
8. Bitch owner is responsible for any vet bills occurred because of injury by the female to the male dog.

9. It is the bitch owner's responsibility to advise me of any habits the dog may have that could possibly present a problem in giving adequate and safe care while in my care, and also to furnish any instructions and medication for any special care required.
10. If ownership of bitch changes during whelp or before puppies are 6 weeks old, the stud owner is not required to sign litter registration papers.
11. If the bitch does not whelp any live puppies following a second breeding, no fees will be returned and there is no commitment on the stud dog owner's part to provide any more service.
12. It is agreed between the stud owner & the owner of the bitch that puppies from this breeding will be sold exclusively by the owner of the bitch, and sale of the puppies will not be made to any owner, employee, agent, or individual connected with a pet shop, specialty shop, or wholesaler of dogs. Wholesaler meaning any individual that buys puppies in litter lots for their own resale, trades puppies for articles, sells puppies by the litter, etc. In the event that the owner of the bitch does sell any puppy to the a fore mentioned, the stud owner shall take recourse through the courts for damages to her name and damage to the reputation of her male in the amount of \$5,000 The owner of the bitch shall also be responsible for all legal and court costs of the stud owner during this recourse.

13. If puppies are produced we will be invited to view the litter at about 6 weeks old so that we can see firsthand what our stud is capable of producing. If a pick of litter agreement was reached, this or some time shortly after is when we will take the puppy home.

14. I am not required to sign the application for registration of a resulting litter until all fees are paid and all conditions of this contract are met.

15. The period of residence in the stud dog owner's possession shall not exceed seven (5) days unless otherwise agreed upon. Additional days will be subject to a \$5.00 per day boarding fee 16. I will assist in finding the puppies and excellent home by advertising them on my website and other websites I use. There is an extra fee for my service of \$300. I am not responsible for selling all the puppies. It is not guaranteed that any puppies will be sold. It is not my responsibility for vet bills that occur with the puppies.
